As can be seen by the above, the names JOHN, ISAAC, JOSEPH and WILLIAM were used over and over in the names of members of these THRASHER families, as they were in the Bibb County, Ala. families. However, the family names of BARTON and CLOUD are not found in the names of these families, as they are in the Alabama families, which appears to indicate that the Alabama families are the ones who descended from the John Thrasher - Ruth Cloud and John Thrasher - Susan Barton ancestors.

You will recall that in Dr. Marion Thrasher's book published in 1895, in California, he indicated that the earliest known THRASHERS he found were brothers WILLIAM, JOHN and THOMAS. Having traced our line back to Rockingham County, N. C., and since another source indicated that ROBERT THRASHER, son of WILLIAM THRASHER, the "progenitor of the family of this name" who came to Virginia, had five sons, one of whom was JOHN (p. 110 CBD), it is believed that our line descends from WILLIAM, although to date this has not been documented.

It is also known that WILLIAM's brother, THOMAS, who married MARTHA LEE, also had a son named JOHN THRASHER. This family originally settled in Maryland, and there are many records of this JOHN THRASHER. Correspondence I have had with two ladies in Indiana indicate that their ancestors went west, through Tennessee, and they have proof back to the JOHN THRASHER family who settled in Maryland. It is entirely possible, and even probable, that all of these families go back to the generation of the three brothers mentioned above, WILLIAM, THOMAS and JOHN, however this has not been documented, to date.

As we have discussed before, it is believed that DANIEL McCOLLUM's wife was MARY THRASHER, dau. of JOHN and RUTH (CLOUD) THRASHER, inasmuch as they named two of their sons THRASHER McCOLLUM and CLOUD McCOLLUM. Another family closely connected with the THRASHERS and McCOLLUMS was the BETHELL family. These three families were consistently found witnessessing deeds and other legal transactions for each other. Some of you have copies of the Rockingham Co., N.C. map, which shows that these families were living on adjoining land. Could another of JOHN and RUTH THRASHER's daughters have married a BETHELL? Those of you who do not have a copy of the above map may want to order a copy from the Rockingham County Historical Society, P. O. Box 84, Wentworth, N. C. 27375. The price when I ordered mine was

You will notice in the above abstracts that the various members of several other families which were very closely associated, or intermarried, with the THRASHER families, are being included. If you will check the indexes of COUSINS BY THE DOZENS, or the CBD-Supplement, you will find the

names: STUBBLEFIELD (intermarried with the Barton family), WILLIAM CLARK, whose wife was MARGARET THRASHER (dau. of JOSEPH CLOUD THRASHER), LEWIS, (WILLIAM LEWIS mentioned in the will of JOSEPH CLOUD THRASHER as a "relative", CBD-p.126), PETER LEWIS, TALITHA BROWDER (mother of TALITHA COX BROWDER THRASHER and NANCY WASHINGTON BROWDER THRASHER, who married ISAAC and CLOUD THRASHER, in Rockingham Co., N.C.) At this point, it is interesting to note that these BROWDER women were Gr-gr-gr aunts of the writer's husband, JOE PRUETT. His grandfather, WILLIAM HENRY PRUETT (Judge and Maj. in the Civil War), married ANNE E. BROWDER, daughter of ISHAM BROWDER, of Rockingham County, N. C. I guess this makes him a bona fide member of the THRASHER FAMILY, other than by marriage! I haven't yet figured out just what kind of cousin he is to me!

Just recently two of ANNE BROWDER's Journals (diaries) have come to light, which I have published, and which records events just before and immediately following the close of the Civil War, very similar to "Gone With the Wind".

We, together with Dr. Robert and Jane Rainer, recently made a trip to St. Simons Island to meet with Tom Dodd and the Sales Manager for Epworth-by-the-Sea, to solidify arrangements for our Family Reunion in June -- the 23rd. It is hoped that this book will be as accurate as it is possible to have it, in order that inaccurate information will not be perpetuated. Please do not include "heresay" or "legendary" information, unless it is qualified.
- 3 There are some of you who have not as yet been able to determine where your families connect with the Georgia THRASHER FAMILY. We hope you will continue your search for the "missing link" until the deadline for submitting information, which will be shortly after our Reunion. In the event the connecting link cannot be found, SPACE PERMITTING, we will have a special section for your family information, inasmuch as someone may see the book, recognize your family, and be able to furnish the "missing link".
