# THRASHER BOOK

Information has been received from some of you to be included in the new THRASHER book. Some of it has been reviewed, and organization of the material has begun. Some of you have reported that you are presently working on your contribution, and will bring it to the Reunion. It would be virtually impossible to avoid all errors and omissions, however, in order to be as accurate as possible, it is requested that you print, or type if at all possible, in order that spelling, dates, etc. will be correct. Obviously, it would not be possible for me to do research on any particular family, in order to place that family in the proper section, or on a particular line, therefore you should be able to document your information, tracing your line back to one of the published families. That is, by Bible records, or other legal records. There will be a special section for those families whose information I have, but who do not know where they fit into the "big picture". It is hoped that in this way we may be able to establish some "missing links". For those of you who are filling out the Family Group Sheets, please note that they request dates giving the day first instead of month, i.e. Day-Month-Year, instead of Month-Day-Year. It has been noticed that some of these dates are given incorrectly, which would give the wrong dates of birth and marriage. When the final draft is typed on a family, a copy will be mailed to the person who submitted the data, to be proof read, for inaccuracies, omissions, or any necessary corrections which should be made before the book goes to press.

# ROCKINGHAM AND STOKES COUNTIES - NORTH CAROLINA

In checking the records of the above counties, compiled by members of the James Hunter Chapter, N.S.D.A.R., of Madison, North Carolina, in addition to the names of Capt. JOSEPH CLOUD, the THRASHER FAMILY, ISAAC THRASHER, and PETER LEWIS, the following was noted:

"On May 2, 1839, JOHN LAWSON appeared before CHARLES BANNER, a Justice of the Peace of Stokes Co., N.C. and gave oath that he was a brother of JERUSIA HOOKER; that Rev. WILLIAM STEPHENS published the Bans agreeable to the Rules and Customs of the Church; and he married or solemnized the Rites of Matrimony between WILLIAM HOOKER and his sister JERUSIA; that he was about fifteen and lived with his sister until shortly after the Battle of Kings Mountain when he was sent by his father, JOHN LAWSON, now dec'd, to Halifax Co., Va. to live with his relations about two years; hence, he could only testify as to what he had been told by his brother-in-law after that.

"JERUSHA HOOKER was entered on the pension roll of N.C. at the rate of \$43.33 per annum.

Those of you who have copies of Dr. Marion Thrasher's History of the Thrasher Family will recall that one JOHN THRASHER (1730-1806), married ELIZABETH HOOKER, and they became the parents of: STEPHEN, JOSIAH, ELIJAH, ELIAS and JOHN F. THRASHER. According to Dr. Thrasher, STEPHEN (1761-1833) remained in Kentucky; JOSIAH (1763-1849) went to Indiana; ELIJAH went to ) went to Missouri. Records of these THRASHER Georgia, and ELIAS (1765-It is understandable that families appear in records of the above states. this JOHN THRASHER has, in the past, been confused with our JOHN THRASHER who came to Georgia. The name "JOHN THRASHER" has been passed down from generation to generation since that time, which has confused many genealogists researching this family for many years. However, from the above, it would appear that these are all one family -- they appear in the same places, carry the same given names, and when Dr. Thrasher compiled his book, in 1895, there were descendants of these families still living who could provide first-hand information on their families. There are some interesting letters in the back which were received too late for evaluation by Dr. Thrasher.

One letter, from a Dr. J. Dorsey Thrasher, of Forest Hill, W. Va., stated his great-great-grandfather was born in Germany, came to Berkley Co., Va. (now West Virginia). He stated his great-grandfather was Frederic Thrasher, b. Va. Sept. 21, 1769; m. NANCY FILSON in April, 1794; d. 1852. This would appear to be another family, however they were in the area of Virginia adjacent to Kentucky, where some of our Thrasher families were found. Since we have had queries from THRASHERS throughout the Midwest, it was thought some may be descended from this family.

# HARRIET ELIZABETH THRASHER

A query was received some time ago from Mrs. Betty Bourns, 8 Greenwood Lane, Canyon, Texas 79015, trying to trace descendants of HARRIET ELIZABETH THRASHER, at which time she gave the following information:

HARRIET ELIZABETH THRASHER was born 22 Aug 1831, in Georgia; died 14 Oct. 1924; bur. "Y" Cemetery, Atlanta, Texas. She married STERLING HARRISON THOMAS, b. 1837, son of JOSEPH THOMAS (b. 1798 in S.C.) and SUSANNAH (b. 1802 in S.C.) He is bur. in Newnan, Coweta Co., Ga. According to Mrs. Bourns, HARRIET had the following siblings:

- GEORGE lost an arm in the Civil War living in Cass Co., TX.

You will recall that PINCKNEY B. THRASHER was the son of ISAAC THRASHER, JR. and TALITHA C. (BROWDER) THRASHER. It was not known what happened to him after the death of his father, however it was known that he received his distributive share of his father's estate, which would indicate that he had reached his majority by the year 1815. Following is a deed where he is selling to TALITHA C. THRASHER his land in Clarke County, Ga.:

This Indenture made this fourteenth day of February in the year of Georgia our Lord one thousand Eight Hundred and twenty-five Between PINKNEY Clarke County) B. THRASHER of the County and State of Georgia of the one part and TILITHA C. THRASHER of the same place of the other part, Witnesseth that I the said P. B. THRASHER have for and in consideration of the sum of Two Hundred dollars to him in hand paid the receipt whereof is hereby acknowledged hath bargained sold and conveyed and by these presents doth bargain sell and convey unto the said TILITHA C. THRASHER her heirs & assigns all my right title or claim to a certain tract or parcel of land situate lying and being in the county of Clarke and state aforesaid on the waters of Rose Creek joining LIGON & CLARK, MAXEY, for the above mentioned land I hereby relin= quish to TILITHA C. THRASHER my right and title to said land. Given under my hand as a legatee of the estate of I. THRASHER Decd of the county aforesaid To have and my interest in said Land forever to the said TILITHA C. THRASHER to Hold - And I the said P. B. THRASHER do forever warrant and defend the right and title to said land for me and my heirs, against all claim or claims whatsoever. In witness whereof I have hereunto set my hand and seal the day and date above written.
